13 REQUEST FOR 30 DAYS TO RESPOND

14 Now comes Maryam Torben Desfosses, on behalf of New Hampshire Banking  
 15 Department ("Department") in the above captioned matter, and requests that  
 16 the Department be given thirty (30) days from the date this request is  
 17 granted to object to Respondents' Response and Objection to Order to Cease  
 18 and Desist ("Objection") filed by counsel for Assets Recovery Center, LLC,  
 19 d/b/a Assets Recovery Center of Florida, Daniel Ferdinand Coosemans, and  
 20 John R. Olsen ("Respondents").

21 The Objection filed by Respondents' counsel is in response to the  
 22 Department's February 21, 2012 Order to Cease and Desist. While objections  
 23 are made as to each alleged violation, the Objection also motions for the  
 24 Presiding Officer to vacate the Department's Order. JUS 8106.01(c) grants  
 25 an opposing party thirty (30) days to object to a written motion. Due to

1 Departmental workload, additional time is necessary in this matter for the  
2 Department to prepare a response to Respondents' objections and the motion  
3 to vacate the Department's Order.

4 WHEREFORE, Department respectfully requests

5 A. The Presiding Officer grant the Department's request for 30 days from  
6 the date this request is granted to object to Respondent's Response  
7 and Objection to Order to Cease and Desist (which includes a motion to  
8 vacate the Department's Order); and

9 B. Grant such further relief as is just and in the public interest.
