The Department issued to the above named Respondents an Amended Order to 13 Show Cause on April 4, 2011, which Respondents received on April 7, 2011. 14 RSA Chapter 541-A and RSA Chapter 361-A require the Department to hold a 15 hearing on such matter within ten (10) calendar days of a written request 16 for a hearing unless otherwise waived by the Respondents. On May 6, 2011, 17 Respondent Inofin filed a timely request for a hearing and requested that 18 the Amended Order to Show Cause be consolidated with the original Order to 19 Show Cause and Cease and Desist and be heard on May 17, 2011. As of Tuesday, 20 May 10, 2011, the remaining Respondents herein have defaulted. IT IS HEREBY ORDERED that: 21 22 2. Respondent Inofin appear before the New Hampshire Banking Department on 23 Tuesday, May 17, 2011 at 10:00 am, at the New Hampshire Department located at 53 Regional Drive, Suite 200, Concord, New Hampshire 24 25 03301, for the purpose of participating in an adjudicative proceeding, at

which time Respondent Inofin will have the opportunity to demonstrate why

- the relief sought in the Amended Order to Show Cause should not become permanent.
- 3 | 3. Pursuant to RSA 541-A:31, III(b), the legal authorities under which the
- 4 hearing is to be held are: RSA 541-A:30,III, RSA 361-A:3, RSA 361-A:3-a, RSA
- 5 | 361-A:5 and RSA 361-A:11.
- 6 4. The Department's alleged violations against Respondent Inofin in the 7 Amended Order to Show Cause are as follows:
- 8 | Violation #1: Failure to facilitate (RSA 361-A:6-a,V) 1 Count;
- 9 | Violation #2: Violation of Department's January 6, 2011 Cease
- and Desist Order (RSA 361-A:3, I-a, (i)) 1 Count; and
- 11 | Violation #3: Failure to update information with the
- 12 Commissioner (RSA 361-A:2,XII) 1 Count;
- 13 5. The facts as alleged in the Amended Order to Show Cause are herein
- 14 | incorporated by reference.
- 15 | 6. An adjudicative proceeding shall be commenced pursuant to RSA 541-A:31
- 16 | for the purpose of permitting Respondent Inofin to show compliance with the
- 17 | stated violations.
- 18 | 7. Each party has the right to have an attorney present to represent the
- 19 | party at the party's expense, or may represent itself or himself. Respondent
- 20 | Inofin's Counsel has filed a notice of appearance.
- 21 8. Maryam Torben Desfosses, Hearings Examiner, New Hampshire Banking
- 22 | Department is designated as Hearings Examiner in this matter with authority
- 23 | to represent the public interest within the scope of the Department's
- 24 | authority. The Hearings Examiner shall have the status of a party to this
- 25 | proceeding.

- 9. A Presiding Officer will be delegated to preside over this matter pursuant to RSA 383:7-a and see also RSA 541-A:1,XV.
- 3 | 10. Any proposed exhibits shall be pre-marked, for identification only, and
- 4 | filed with the Department and provided to the opposing party by Thursday,
- 5 | May 12, 2011. The Hearings Examiner shall pre-mark the Department's exhibits
- 6 | with Arabic numbers. Respondent Inofin shall pre-mark exhibits with capital
- 7 | letters. An index/list of exhibits providing a brief description of each
- 8 | exhibit with its corresponding pre-marked number or letter shall be filed by
- 9 | both parties simultaneous with the filing of exhibits.
- 10 | 11. The parties shall exchange a list of all exhibits and witnesses to be
- 11 | called at the hearing with a brief summary at the hearing, and shall at the
- 12 | same time file a copy of their respective lists with the Presiding Officer.
- 13 | 12. All periods referenced in this notice shall be calendar days. If the
- 14 | last day of the period so computed falls on a Saturday, Sunday, or legal
- 15 | holiday, then the time period shall be extended to include the first
- 16 | business day that is not a Saturday, Sunday, or legal holiday.
- 17 | 13. The Department shall have the burden of setting forth a prima facie
- 18 | case, then Respondent Inofin shall have the burden of showing compliance
- 19 | with applicable law by a preponderance of the evidence.
- 20 | 14. Respondent Inofin's failure to appear at the time, date, and place
- 21 specified may result in the hearing being held in absentia and/or default
- 22 || ruling in favor of the Department, without further notice or opportunity to
- 23 | be heard.
- 24 | 15. The entirety of all verbal proceedings shall be recorded verbatim by the
- 25 Department. Upon request of any party, or upon the Presiding Officer's own
 - initiative, such record shall be transcribed by a certified court reporter
