- 5. The facts as alleged in the Complaint, Order to Show Cause and Cease and Desist are herein incorporated by reference.
- 6. An adjudicative proceeding shall be commenced pursuant to RSA 541-A:31 for the purpose of permitting the above named Respondents to show compliance with the stated violations.
- 7. Each party has the right to have an attorney present to represent the party at the party's expense, or may represent itself or himself. If the

- Respondents elect to be represented by Counsel, said Counsel shall file a notice of appearance at the earliest possible date.
- 3 | 8. Ryan McFarland, Hearings Examiner; and Maryam Torben-Desfosses, Hearings
- 4 | Examiner, New Hampshire Banking Department are designated as Hearings
- 5 | Examiners in this matter with authority to represent the public interest

- 13 exhibits with Arabic numbers. The Respondents shall pre-mark exhibits with
- 14 | capital letters. An index/list of exhibits providing a brief description of
- 15 | each exhibit with its corresponding pre-marked number or letter shall be
- 16 | filed by both parties simultaneous with the filing of exhibits.
- 17 | 11. The parties shall exchange a list of all exhibits and witnesses to be
- 18 | called at the hearing with a brief summary at the hearing, and shall at the
- 19 | same time file a copy of their respective lists with the Presiding Officer.
- 20 | 12. All periods referenced in this notice shall be calendar days. If the
- 21 | last day of the period so computed falls on a Saturday, Sunday, or legal
- 22 | holiday, then the time period shall be extended to include the first
- 23 | business day that is not a Saturday, Sunday, or legal holiday.
- 24 | 13. The Department shall have the burden of setting forth a prima facie
- 25 case, then the Respondents shall have the burden of showing compliance with

- 1 | applicable law by a preponderance of the evidence.
- 2 | 14. Any Respondent's failure to appear at the time, date, and place
- 3 || specified may result in the hearing being held in absentia and/or default
- 4 | ruling in favor of the Department, without further notice or opportunity to
- 5 | be heard.
- 6 | 15. The entirety of all verbal proceedings shall be recorded verbatim by the
- 7 Department. Upon request of any party, or upon the Presiding Officer's own
- 8 | initiative, such record shall be transcribed by a certified court reporter
- 9 designated by the Presiding Officer, and that all costs shall be borne
- 10 | solely by the requesting party.
- 11 | 16. Each party has the right to have the Department provide a certified
- 12 | shorthand court reporter at the requesting party's expense. Any such request
- 13 | shall be submitted in writing to the Presiding Officer at least 10 days
- 14 prior to the hearing.
- 15 | 17. All documents shall be filed with the Presiding Officer in the form of an
- 16 | original and one (1) copy and shall bear a certification that a copy is being
- 17 delivered to Hearings Examiners and any other parties to this matter in
- 18 | accordance with applicable laws. All documents shall be filed by mailing or
- 19 delivering them to the New Hampshire Banking Department, ATTN: Presiding
- 20 Officer 11-125, 53 Regional Drive, Suite 200, Concord, NH 03301. Filing by
- 21 | facsimile or electronic transmission shall not be accepted.
- 22 | 18. The parties may submit Proposed Orders, which shall include findings of
- 23 || fact and conclusions of law, separately stated, no later than ten (10) days
- 24 | following conclusion of the hearing(s) in this matter.
