10 CONSENT ORDER

11 I. For purposes of settling the above-referenced matter, among other  
12 things, the New Hampshire Banking Department (hereinafter referred to  
13 as "the Department") and Respondents, do hereby enter this Agreement  
and stipulate to the following:

- 14 1. The Respondents are or were licensed to conduct mortgage brokering  
15 activity by the Department pursuant to RSA 397-A:3.
- 16 2. The Department began an examination of Respondent entity on  
17 December 22, 2005.
- 18 3. The examination invoice remained unpaid by Respondent until they  
19 received the initial order in this cause.

20 II. For purposes of amicably resolving and closing the above-referenced  
21 matters the Respondent agrees to the following terms and conditions and the  
Department accepts the same:

- 22 1. The Respondent agrees that it has voluntarily entered into this  
23 Agreement without reliance upon any discussions between the  
24 Department and Respondent, without promise of a benefit of any kind  
(other than concessions contained in this Agreement), and without  
25 threats, force, intimidation, or coercion of any kind. The  
Respondent further acknowledges its understanding of the nature of  
the offenses stated above, including the penalties provided by law.

- 1        2.     The Respondent agrees to waive any and all rights to a hearing and  
2            appeal thereof.
- 3        3.     The Respondent agrees that it will not deny the factual basis for  
4            this Agreement to which it has stipulated above and will not give  
5            conflicting statements about such facts or its involvement in the  
6            stipulated facts.
- 7        4.     The Respondent agrees that all terms of this Agreement are  
8            contractual and none is a mere recital.
- 9        5.     The Respondents will pay a fine for violation of RSA 397-A:12 in the  
10           amount of \$500 to be submitted contemporaneously herewith.
- 11       6.     The Department acknowledges Respondent has surrendered their license  
12           and agrees to take no further action against Respondent.
- 13       7.     The Respondent acknowledges that failure to make payment as agreed  
14           above or further violations of law will result in license action and  
15           additional administrative fines.
- 16       8.     Each person who signs this Consent Order in a representative  
17           capacity warrants that his or her execution of this Consent Order is  
18           duly authorized, executed, and delivered by and for the entity for  
19           which he signs.

20 This Agreement represents the complete and final resolution of, and discharge  
21 of any basis for any civil or administrative proceeding by the Department  
22 against the Respondent for violations arising as a result of or in connection  
23 with any actions or omissions by the Respondent through the date of this  
24 Order as it applies to the current allegations; provided, however, this  
25 release does not apply to facts not known by the Department or not otherwise  
provided by the Respondent to the Department as of the date of this Order.  
The Department expressly reserves its right to pursue any administrative or  
civil action or remedy available to it should the Respondent breach this  
Agreement or in the future violate the Act or rules and orders promulgated  
thereunder. Nothing in this Agreement, absent default, will preclude the  
Respondent's re-instatement as a mortgage broker in New Hampshire.
