Pursuant to RSA 397-A:21, the Commissioner has the authority to suspend, revoke or deny any license and to impose administrative penalties of up to \$2,500.00 for each violation of New Hampshire banking law and rules.

Pursuant to RSA 383:10-d, the Commissioner shall investigate conduct 5 that is or may be an unfair or deceptive act or practice under RSA 358-A and 6 exempt under RSA 358-A:3,I or that may violate any of the provisions of 7 Titles XXXV and XXXVI and administrative rules adopted thereunder. The 8 Commissioner may hold hearings relative to such conduct and may order 9 10 restitution for a person or persons adversely affected by such conduct. The Commissioner may utilize all remedies available under the Consumer 11 Protection Act. 12

NOTICE OF RIGHT TO REQUEST A HEARING

13

The above named Respondent has the right to request a hearing on this 14 Order to Show Cause, as well as the right to be represented by counsel at 15 the Respondent's own expense. All hearings shall comply with RSA 541-A. Any 16 such request for a hearing shall be in writing, and signed by the Respondent 17 18 or the duly authorized agent of the above named Respondent, and shall be delivered either by hand or certified mail, return receipt requested, to the 19 Banking Department, State of New Hampshire, 53 Regional Drive, Suite 200, 20 Concord, NH 03301. Such hearings will be scheduled within 10 days of the 21 Department's receipt of the request. If the Respondent fails to appear at the 22 23 hearing after being duly notified, such person shall be deemed in default, and the proceeding may be determined against the Respondent upon consideration of 24 25 the Order to Show Cause, the allegations of which may be deemed to be true.

If the above named Respondent fails to request a hearing within 30 1 calendar days of receipt of such order or reach formal settlement with the 2 Department within that time frame, then such person shall likewise be deemed 3 in default, and the orders shall, on the thirty-first day, become permanent, 4 5 and shall remain in full force and effect until and unless later modified or vacated by the Commissioner, for good cause shown. 6

The above named Respondent shall show cause why, in addition listed in to the penalties Paragraph 1 above, the administrative fine of \$1,000.00 in the July 16, 2007 Consent Order should not be voided and replaced with the original

- 5. RSA 397-A:17,I(a) provides that the Commissioner may by order, upon due notice and opportunity for hearing, assess penalties or deny, suspend, or revoke a license if it is in the public interest and the respondent, or licensee, any partner, officer, member, or director, any person occupying a similar status or performing similar functions, or any person directly or indirectly controlling the respondent, or licensee has violated any provision of RSA Chapter 397-A or rules thereunder. The above named Respondent violated RSA 397-A:2, III by breaching the Consent Orders as alleged above.
- 6. RSA 397-A:17,I(e) provides that licensees are prohibited from making false or misleading statements to the Commissioner or in any reports to the Commissioner. The above named Respondent violated this provision on at least one occasion as alleged above. The Respondent has failed to pay the remaining \$5,750.00 of the \$6,250.00 statutory penalty and failed to pay the \$1,000.00 administrative penalty.
- 7. RSA 397-A:18,I provides that the Department may issue a complaint setting forth charges whenever the Department is of the opinion that the licensee or person over whom the Department has

jurisdiction, has violated any provision of RSA Chapter 397-A or 1 orders thereunder. 2 8. RSA 397-A:21, IV provides that any person who, either knowingly or 3 negligently, violates any provision of RSA Chapter 397-A, may 4 5 upon hearing, and in addition to any other penalty provided for 6 by law, be subject to an administrative fine not to exceed 7 \$2,500.00, or both. Each of the acts specified shall constitute a separate violation, and such administrative action or fine may 8 imposed in addition to any criminal penalties or civil 9 be 10 liabilities imposed by New Hampshire Banking laws. III. RELIEF REQUESTED 11 The staff of the Department requests the Commissioner take the following 12 action: 13 1. Find as fact the allegations contained in section I of this Staff 14 15 Petition; 2. Make conclusions of law relative to the allegations contained in 16 section II of this Staff Petition; 17 18 3. Assess fines and administrative penalties in accordance with RSA 19 397-A:21, for violations of Chapter 397-A, in the number and amount equal to the violations set forth in section II of this Staff 20 Petition; and 21 4. Take such other administrative and legal actions as necessary for 22 23 enforcement of the New Hampshire Banking Laws, the protection of New Hampshire citizens, and to provide other equitable relief. 24 25
