AGREEMENT

AGREEMENT by and between the New Hampshire Banking Department ("the Department") and Americor Lending Group Inc. (ALG), with a principal place of business at 18111 Von Karman Avenue 7th Floor, Irvine, CA 92612:

WHEREAS, the Department enforces the provisions of RSA 397-A governing the requirements of licensure for Mortgage Bankers and Brokers;

WHEREAS, ALG acknowledges it violated 397-A:13 by its failure to submit its financial statement in a timely manner;

WHEREAS, ALG wishes to avoid formal license action;

NOW THEREFORE, in consideration of the premises, representations, and agreements contained herein, the Department and ALG agrees as follows;

1. ALG will immediately pay the Department an administrative fine for violation of the Chapter in the amount of \$1,000.00.
2. ALG will immediately submit its 2006 financial statement.
3. ALG will pay the statutory fine for late submission of a financial statement within thirty days of being invoiced.
4. ALG agrees that any subsequent violations of law pertaining to its Mortgage Banker/Broker activities shall be grounds for further action being taken against it.
5. ALG agrees that it will not deny the factual basis for this Agreement to which it has stipulated above and will not give conflicting statements about such facts or its involvement in the stipulated facts.

1 6. Violations of the Agreement shall constitute sufficient grounds
2 for license denial, suspension or revocation or initiation of
3 administrative action that may result in the imposition of fines
4 for the activity acknowledged above.

5 7. This Agreement may be amended or modified only by a written
6 instrument signed by the parties.

7 8. That a public order reflecting the terms of this agreement will
8 be entered after the agreement's execution by the Commissioner.
