NOTICE OF ORDER

This Order commences an adjudicative proceeding under the provisions of RSA 397-A:18 II and BAN 200 et seq.

LEGAL AUTHORITY AND JURISDICTION

Pursuant to RSA 397-A:18 II, the Banking Department of the State of New Hampshire (hereinafter the "Department") has the authority to issue and cause to be served an order requiring any person engaged in any act or practice constituting a violation of RSA 397-A or any rule or order thereunder, to cease and desist from violations of RSA 397-A.

Pursuant to RSA 397-A:21, the Commissioner has the authority to suspend, revoke or deny any license and to impose administrative penalties of up to \$2,500.00 for each violation of New Hampshire banking law and rules.

Pursuant to RSA 383:10-d, the Commissioner shall have exclusive authority and jurisdiction to investigate conduct that is or may be an unfair or deceptive act or practice under RSA 358-A and exempt under RSA 358-A:3, I or that may violate any of the provisions of Titles XXXV and XXXVI and administrative rules adopted thereunder. The Commissioner may hold hearings relative to such conduct and may order restitution for a person or persons adversely affected by such conduct. Nothing in this cause will impair a consumer's right of recovery under that statute.

NOTICE OF RIGHT TO REQUEST A HEARING

The above named respondent has the right to request a hearing on this Cease and Desist Order, as well as the right to be represented by counsel. If the person to whom a cease and desist order is issued fails to request a hearing within 30 calendar days of receipt of such order, then such person shall be deemed in default, and the order shall, on the thirty-first day, become permanent and shall remain in full force and effect until and unless later modified or vacated by the commissioner, for good cause shown. Any such request for a hearing shall be in writing, signed by the respondent or by the duly authorized agent of the above named respondent, and shall be delivered either by hand or certified mail, return receipt request, to the Banking Department, State of New Hampshire, 64B Old Suncook Road, Concord, NH 03301.

17 A hearing shall be held not later than 10 days after the request for such 18 hearing is received by the commissioner. Within 20 days of the date of any such 19 hearing the commissioner shall issue a further order either vacating the cease 20 and desist order or making it permanent as the facts require. All hearings 21 shall comply with 541-A. If the person to whom a cease and desist order is 22 issued fails to appear at the requested hearing after being duly notified of 23 the date and time, such person shall be deemed in default, and the proceeding 24 may be determined against him or her upon consideration of the cease and desist 25 order, the allegations of which may be deemed to be true.

	WHEREAS, finding it necessary and appropriate and in the public

9	if proved true and correct, form the legal basis of the relief requested,			
10	It is hereby ORDERED, that:			
11	1. The Respondents shall immediately cease engaging in the			
12	activity of a mortgage banker / broker on residential property			
13	in New Hampshire; and			
14	2. The Respondents shall repay to consumers all commissions			
	collected as a result of their unlicensed activity; and			
15	3. Respondent Greenfield shall show cause why it should not be			
16	ordered to pay \$2,500.00 for violations of the Chapter; and			
17	4. Respondent Rosenfield shall show cause why he should not be			
18	ordered to pay \$2,500.00 for violations of the Chapter; and			
19	5. Respondent Greenblatt shall show cause why it should not be			
20	ordered to pay \$2,500.00 for violations of the Chapter; and			
21	6. Failure to request a hearing within 30 days of the date of			
22	receipt of this Order shall result in a default judgment being			
23	rendered, administrative penalties being imposed upon the			
	defaulting Respondents, refunds of all commissions being

STATEMENT OF ALLEGATIONS

I. The staff of the Banking Department, State of New Hampshire (hereinafter referred to as the "Department") alleges the following facts:

 During an examination of a licensed entity, the Examiner in Charge ("EIC") noted the licensee had accepted mortgage originations from an entity they knew as Greenfield Financial Group Inc (hereinafter "Respondent Greenfield").

2. Respondent Greenfields's primary business location is North Miami, FL.

- 3. Respondent Daniel Rosenfield (hereinafter "Respondent Rosenfield") is the President/Director and Secretary of Respondent Greenfield.
- 4. Respondent Paul Greenblatt (hereinafter "Respondent Greenblatt") is the Vice-President/Director and Treasurer of Respondent Greenfield.
- 5. The EIC noted that Respondent Greenfield originated at least 1 loan, then placed that loan with the licensed entity in expectation of compensation.

6. Respondent Greenfield was not licensed as a mortgage broker nor was it

- entitled to any compensation. Respondent Greenfield engaged in 1 activity that required it to obtain a license. 2 The staff of the Banking Department, State of New Hampshire alleges the II. 3 following issues of law: 4 1. The Banking Department ("Department"), has jurisdiction over the 5 licensing and regulation of persons engaged in first mortgage banker / 6 broker activities pursuant to NH RSA 397-A:3. 7 2. Pursuant to the New Hampshire Banking laws, RSA 397-A:3 requires any 8 person not exempt under RSA 397-A:4 that, in its own name or on behalf 9 of other persons, engages in the business of making or brokering first 10 mortgage loans secured by real property located in this state shall be 11 required to obtain a license from the banking department. 3. Pursuant to NH RSA 397-A:18, the Department has the power to issue and 12 to serve an order requiring persons to cease and desist from violations 13 of the chapter whenever it has reasonable cause to believe that any 14 person has engaged in any act or practice constituting a violation of 15 the banking laws, or any rule or order thereunder. Respondent has 16 violated RSA 397-A:3 by conducting unlicensed mortgage banker / broker 17 activities in New Hampshire.
 - Pursuant to RSA 397-A:1 originators may only work for one mortgage broker at a time.

- 5. Pursuant to RSA 397-A:16 only licensed mortgage brokers and bankers are entitled to retain commissions for their services.
- 6. Pursuant to RSA 397-A:21 any person who, either knowingly or negligently, violates any provision of this chapter may, upon notice and opportunity for hearing, and in addition to any such other penalty provided for by law, be subject to suspension, revocation or denial of any registration or license, including forfeiture of any application fee,

or an administrative fine not to exceed \$2,500, or both. Each of the acts specified shall constitute a separate violation, and each such administrative action or fine may be imposed in addition to any criminal or civil penalties imposed.

7. Also pursuant to RSA 397-A:21 every person who directly or indirectly controls a person liable under this section, every partner, principal executive officer or director of such person, every person occupying a similar status or performing a similar function, every employee of such person who materially aids in the act constituting the violation, and every licensee or person acting as a common law agent who materially aids in the acts constituting the violation, either knowingly or negligently, may, upon notice and opportunity for hearing, and in addition to any other penalty provided for by law, be subject to suspension, revocation, or denial of any registration or license, including the forfeiture of any application fee, or the imposition of an administrative fine not to exceed \$2,500, or both.

8. Pursuant to RSA 383:10-d, the commissioner shall have exclusive authority and jurisdiction to investigate conduct that is or may be an unfair or deceptive act or practice under RSA 358-A and exempt under RSA 358-A:3, I or that may violate any of the provisions of Titles XXXV and XXXVI and administrative rules adopted thereunder. The commissioner may hold hearings relative to such conduct and may order restitution for a person or persons adversely affected by such conduct.

RELIEF REQUESTED

The staff of the Banking Department requests the Commissioner take the following action:

 Find as fact the allegations contained in section I of the Statement of Allegations of this petition.

15	to request that the Banking Department Commissioner take additional			
16	administrative action. Nothing herein shall preclude the Department from			
	bringing additional enforcement action under RSA 397-A or the regulations			
17	thereunder.
