Default Judgment

The Commissioner of Hampshire Banking the New Department ("Department") issued an Order to Show Cause ("Order") against the Respondents Loancity, Inc. ("Respondent Loancity"), Banc of Strategic Investments Corporation ("Respondent Banc of America Strategic Investments Corporation"), Richard D. Soukoulis ("Respondent Soukoulis"), Nicholas Labao ("Respondent Labao"), William Dallas ("Respondent Dallas"), Gary Tsuyuki ("Respondent Tsuyuki"), Rodger Rickard ("Respondent Rickard") and Mark MacLennan ("Respondent MacLennan") on January 15, 2009 via U.S. Certified Mail Return Receipt requested. The Order was returned to the Department as "Not Deliverable, Unable to Forward."

The Commissioner accepted service of the Order on behalf of the above named Respondents on March 3, 2009. The Respondents had thirty (30) days from March 3, 2009 to request a hearing or reach a settlement with the

- Department. The Respondents failed to request a hearing or reach a settlement with the Department on or before April 2, 2009 (which is thirty days from March 3, 2009) as required to avoid Default.
- It is hereby ORDERED, that:

- 1. By operation of law, a default judgment was entered against Respondents on April 3, 2009; and
 - 2. The allegations contained in the Order hereby deemed true; and
 - 3. Respondent Loancity shall immediately pay to the Department an administrative fine in the amount of \$2,500.00;
 - 4. Respondent Banc of America Strategic Investments Corporation shall immediately pay to the Department an administrative fine in the amount of \$2,500.00;
 - 5. Respondent Soukoulis shall immediately pay to the Department an administrative fine in the amount of \$5,000.00;
 - 6. Respondent Labao shall immediately pay to the Department an administrative fine in the amount of \$2,500.00;
 - 7. Respondent Dallas shall immediately pay to the Department an administrative fine in the amount of \$2,500.00;
 - 8. Respondent Tsuyuki shall immediately pay to the Department an administrative fine in the amount of \$2,500.00;
 - 9. Respondent Rickard shall immediately pay to the Department an administrative fine in the amount of \$2,500.00;
 - 10.Respondent MacLennan shall immediately pay to the Department an administrative fine in the amount of \$2,500.00;

1	11.Respondents shall immediately pay to the Department the outstanding
2	examination invoice totaling \$3,365.00;
3	12.Each of the above named Respondents shall be jointly and severally
4	liable for the amounts in Paragraph 3 through 11 above; and
5	13.Respondent Loancity's license is hereby revoked.
