It is hereby ORDERED, that:

- By operation of law, a default judgment was entered against Respondents on February 16, 2009;
- 2. The allegations contained in the January 5, 2009 Order to Show Cause are hereby deemed true;
- 3. Respondent BSM Financial shall immediately pay to the Department an administrative fine for a violation of RSA Chapter 397-A penalties in the amount of \$2,500.00;
- 4. Respondent KJ Financial shall immediately pay to the Department an administrative fine for a violation of RSA Chapter 397-A in the amount of \$2,500.00;
- 5. Respondent Palm Harbor shall immediately pay to the Department an administrative fine for a violation of RSA Chapter 397-A in the amount of \$2,500.00;
- 6. Respondent Cummins shall immediately pay to the Department an administrative fine for two (2) violations of RSA Chapter 397-A in the amount of \$5,000.00;
- 7. Respondent Todd shall immediately pay to the Department an administrative fine for two (2) violations of RSA Chapter 397-A in the amount of \$5,000.00;
- 8. Respondents shall immediately pay to the Department the outstanding exam invoice totaling \$5,215.00;
- 9. Each of the above named Respondents shall be jointly and severally
