10 Default Judgment

11 The Commissioner of the New Hampshire Banking Department  
 12 ("Department") issued an Order to Show Cause against Respondent Imperial  
 13 Lending, LLC (d/b/a Imperial Wholesale Lending) ("Respondent Imperial"),  
 14 Respondent Amy Jaeger ("Respondent A. Jaeger"), Respondent Larry Jaeger  
 15 ("Respondent L. Jaeger") and Respondent Mike Stanki ("Respondent Stanki") on  
 16 February 3, 2010 via U.S. Certified Mail Return Receipt requested. The  
 17 Order to Show Cause was returned to the Department on February 16, 2010 and  
 18 the Commissioner took service on February 19, 2010. The Respondents had  
 19 thirty (30) days from February 19, 2010 to request a hearing or reach a  
 20 settlement with the Department. The Respondents failed to request a hearing  
 21 or reach a settlement with the Department on or before March 21, 2010 (which  
 22 is thirty days from February 19, 2010) as required to avoid Default.

23 It is hereby ORDERED, that:

- 24 1. By operation of law, a default judgment was entered against  
 25 Respondents on March 22, 2010;

- 1        2. The allegations contained in the February 3, 2010 Order to Show Cause  
2            are hereby deemed true;
- 3        3. Respondent Imperial shall immediately pay to the Department an  
4            administrative fine for seven (7) violations of RSA Chapter 397-A in  
5            the amount of \$17,500.00;
- 6        4. Respondent A. Jaeger shall immediately pay to the Department an  
7            administrative fine for eight (8) violations of RSA Chapter 397-A in  
8            the amount of \$20,000.00;
- 9        5. Respondent L. Jaeger shall immediately pay to the Department an  
10           administrative fine for eight (8) violations of RSA Chapter 397-A in  
11           the amount of \$20,000.00;
- 12       6. Respondent Stanki shall immediately pay to the Department an  
13           administrative fine for seven (7) violations of RSA Chapter 397-A in  
14           the amount of \$17,500.00;
- 15       7. Respondent Imperial shall immediately pay to the Department the  
16           outstanding exam invoice totaling \$850.00;
- 17       8. Respondent Imperial shall immediately pay to the Department \$3,500.00  
18           for failing to timely provide examination materials;
- 19       9. Respondent Imperial shall immediately pay to the Department \$2,500.00  
20           for failing to file the 2007 annual report;
- 21       10. Each of the above named Respondents shall be jointly and severally  
22           liable; and

1 11. Respondent Imperial's license is hereby revoked.
