11 Default Judgment

12 The Commissioner of the New Hampshire Banking Department
 13 ("Department") issued an Order to Show Cause against Respondent American
 14 Mortgage Express Corp (d/b/a American Residential Mortgage) ("Respondent
 15 American Mortgage Express"), Respondent Donald Haberle ("Respondent
 16 Haberle"), Respondent Jack G. Mondel ("Respondent Mondel") and Respondent
 17 William JS Kelley ("Respondent Kelley") on January 28, 2010 via U.S.
 18 Certified Mail Return Receipt requested. The Order to Show Cause was
 19 returned to the Department on February 8, 2010 and the Commissioner took
 20 service on February 12, 2010. The Respondents had thirty (30) days from
 21 February 12, 2010 to request a hearing or reach a settlement with the
 22 Department. The Respondents failed to request a hearing or reach a
 23 settlement with the Department on or before March 14, 2010 (which is thirty
 24 days from February 12, 2010) as required to avoid Default.

1 It is hereby ORDERED, that:

- 2 1. By operation of law, a default judgment was entered against
3 Respondents on March 15, 2010;
- 4 2. The allegations contained in the January 28, 2010 Order to Show Cause
5 are hereby deemed true;
- 6 3. Respondent American Mortgage Express shall immediately pay to the
7 Department an administrative fine for three (3) violations of RSA
8 Chapter 397-A in the amount of \$7,500.00;
- 9 4. Respondent Haberle shall immediately pay to the Department an
10 administrative fine for three (3) violations of RSA Chapter 397-A in
11 the amount of \$7,500.00;
- 12 5. Respondent Mondel shall immediately pay to the Department an
13 administrative fine for three (3) violations of RSA Chapter 397-A in
14 the amount of \$7,500.00;
- 15 6. Respondent Kelley shall immediately pay to the Department an
16 administrative fine for three (3) violations of RSA Chapter 397-A in
17 the amount of \$7,500.00;
- 18 7. Respondent American Mortgage Express shall immediately pay to the
19 Department \$2,500.00 for failing to file the 2007 annual report;
- 20 8. Each of the above named Respondents shall be jointly and severally
21 liable; and
- 22 9. Respondent American Mortgage Express's license is hereby revoked.
