10 Default Judgment

11 The Commissioner of the New Hampshire Banking Department
 12 ("Department") issued an Order to Show Cause against Respondent Brook Trout
 13 Mortgage Inc. ("Respondent Brook Trout Mortgage"), Respondent Jonathan H.
 14 Beecher ("Respondent J. Beecher"), Respondent Kristen M. Beecher
 15 ("Respondent M. Beecher") and Respondent David M. Geddes ("Respondent
 16 Geddes") on March 18, 2010 via U.S. Certified Mail Return Receipt requested.
 17 The Order to Show Cause was returned to the Department on April 20, 2010 and
 18 the Commissioner took service on April 22, 2010. The Respondents had thirty
 19 (30) days from April 22, 2010 to request a hearing or reach a settlement
 20 with the Department. The Respondents failed to request a hearing or reach a
 21 settlement with the Department on or before May 22, 2010 (which is thirty
 22 days from April 22, 2010) as required to avoid Default.

23 It is hereby ORDERED, that:

- 24 1. By operation of law, a default judgment was entered against
 25 Respondents on May 23, 2010;

- 1 2. The allegations contained in the March 18, 2010 Order to Show Cause
2 are hereby deemed true;
- 3 3. Respondent Brook Trout Mortgage shall immediately pay to the
4 Department an administrative fine for three (3) violations of RSA
5 Chapter 397-A in the amount of \$7,500.00;
- 6 4. Respondent J. Beecher shall immediately pay to the Department an
7 administrative fine for three (3) violations of RSA Chapter 397-A in
8 the amount of \$7,500.00;
- 9 5. Respondent M. Beecher shall immediately pay to the Department an
10 administrative fine for three (3) violations of RSA Chapter 397-A in
11 the amount of \$7,500.00;
- 12 6. Respondent Geddes shall immediately pay to the Department an
13 administrative fine for three (3) violations of RSA Chapter 397-A in
14 the amount of \$7,500.00;
- 15 7. Respondent Brook Trout Mortgage shall immediately pay to the
16 Department the outstanding exam invoice totaling \$2,885.00;
- 17 8. Respondent Brook Trout Mortgage shall immediately pay to the
18 Department \$200.00 for the late filing of the financial statement;
- 19 9. Each of the above named Respondents shall be jointly and severally
20 liable; and
- 21 10. Respondent Brook Trout Mortgage's license is hereby revoked.
