Re: Notice of Data Event

To Whom It May Concern:

We represent CASTO located at 250 Civic Center Drive, Suite 500, Columbus, Ohio 43215, and are writing to notify your office of an event that may affect the security of certain personal information relating to one (1) New Hampshire resident. This notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, CASTO does not waive any rights or defenses regarding the applicability of New Hampshire law, the applicability of the New Hampshire data event notification statute, or personal jurisdiction.

Nature of the Data Event

On December 9, 2023, CASTO identified suspicious activity within its computer network. In response, CASTO immediately took its computer network offline and commenced a thorough investigation of the suspicious activity. Through this investigation, CASTO determined that certain files were viewed and copied without authorization from a portion of its network between December 8 and December 9, 2023.

CASTO then engaged in a time intensive and detailed review of those files to determine what information was present and to whom it related. CASTO completed that review on August 22, 2024.

Subsequently, CASTO had to undertake additional efforts in reviewing its internal files to validate and identify the contact information for those potentially impacted to issue written notice. CASTO had to retain third party resources to assist with identifying the _____ for individuals as well.

Notice to New Hampshire Resident

On or about November 22, 2024, CASTO began providing written notice of this event to impacted individuals. On or about November 27, 2024, CASTO provided an additional set of written notices regarding this event, which includes one (1) New Hampshire resident. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

Other Steps Taken and To Be Taken

Upon notice, CASTO moved quickly to investigate and respond to the event, assess the security of CASTO systems, and identify potentially affected individuals. Further, CASTO notified federal law enforcement regarding the event.

CASTO is committed to safeguarding the privacy and security of information. As such, CASTO implemented additional security measures within its computer network and completed a review of its internal policies and procedures to mitigate the possibility of any reoccurrence of this type of event.

CASTO is providing access to credit monitoring services for _____, through Experian, to individuals receiving written notification of this event, at no cost to these individuals.

Additionally, CASTO is providing impacted individuals with guidance on how to better protect against identity theft and fraud, information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

CASTO is also providing written notice of this event to relevant state regulators, as necessary.

Monitor Your Accounts

Under current U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
