## Grant and Funding Assistance Possibilities for New Hampshire's Airports

New Hampshire's airports may have access to a number of grants, loans, or other funding assistance programs from a variety of sources. Each program offers different opportunities for different components of airports. Whether an airport sponsor needs assistance with their operating budget, dealing with wildlife issues, planning sustainability features into their airports, or economic development projects, there are many resources offering assistance to those who apply.

Below is only a *sample* of some grant resources that airport sponsors may have an interest in. Many other programs exist including loans and other partnership opportunities that may be worth investigating too.

No preference, recommendation, or endorsement is given by this sample list and all airport sponsors are encouraged to do additional research to find program(s) that best fit their needs.

## FEDERAL GRANT PROGRAMS
