


Figure 1.2-1. Project Location




Figure 2.2-1. Increase between 2015 and 2040 No Build Average Annual Weekday Traffic on NH 102 and Roadways Used to Bypass NH 102




Figure 3.6-3. Alternative B, Sheet 1 of 2




Figure 3.6-4. Alternative B, Sheet 2 of 2




Figure 3.6-5. Alternative C, Sheet 1 of 3




Figure 3.6-6. Alternative C, Sheet 2 of 3




Figure 3.6-7. Alternative C, Sheet 3 of 3




Figure 3.6-11. Alternative F, Sheet 1 of 2




Figure 3.6-12. Alternative F, Sheet 2 of 2




Figure 4.1-1. Project Location




Figure 4.2-1. I-93 Exits 4 and 5




Figure 4.2-2. Existing Condition LOS




Figure 4.2-3. No Build LOS




Figure 4.2-4. Alternative A LOS




Figure 4.2-5. Alternative B LOS




Figure 4.2-6. Alternative C LOS




Figure 4.2-7. Alternative D LOS




Figure 4.2-8. Alternative F LOS




Figure 4.3-1. Land Use




Figure 4.3-2. Zoning




Figure 4.5-1. Noise Monitoring Locations




Figure 4.5-2. Noise Sensitive Areas for Traffic Noise Modeling




Figure 4.5-3. Undeveloped Lands 2040 Noise Contours, Alternative A




Figure 4.7-1. Socioeconomic Conditions




Figure 4.9-1. Soils within 500 Feet of the Build Alternative




Figure 4.10-1. Contaminated Properties and Hazardous Materials




Figure 4.11-1. Surface Water




Figure 4.11-2. Impaired Sites and Chloride Study Sampling




Figure 4.12-1. Wetlands Overview




Figure 4.12-2. Prime Wetlands




Figure 4.12-3. Wetland Detail 1




Figure 4.12-4. Wetland Detail 2




Figure 4.12-5. Wetland Detail 3




Figure 4.12-8. Wetland Detail 6




Figure 4.12-11. Wetland Detail 9




Figure 4.13-1. Groundwater




Figure 4.14-1. Stream Crossings




Figure 4.15-1. Floodplains




Figure 4.16-1. Plant Communities




Figure 4.16-2. Wildlife Habitat




Figure 4.18-2. Area of Potential Effect, Sheet 2 of 3




Figure 4.18-3. Area of Potential Effect, Sheet 3 of 3




Figure 4.18-4. Historic Resources (2007 DEIS)




Figure 4.18-5. Historic Districts (2007 DEIS)




Figure 4.19-1. Parks, Recreation, and Conservation Lands




Figure 5.2-1. Land Use Forecasting Study Area




Figure 5.3-1. Location of Known Developments




Figure 5.3-2. Woodmont Commons Phase I Development and Market Basket Redevelopment Footprints




Figure 5.3-3. Woodmont Commons West (Remainder) Development Footprints under the No Build Condition




Figure 5.3-4. Woodmont Commons West (Remainder) Development Footprints under the Build Condition




Figure 5.3-5. Woodmont Commons East Development Footprints under the No Build Condition




Figure 5.3-6. Woodmont Commons East Development Footprints under the Build Condition




Figure 5.3-7. Derry Industrial Development Footprints
