NOTICE OF HEARING AND APPOINTMENT OF HEARING OFFICER

- A. On October 30, 2019 the New Hampshire Insurance Department ("Department") instituted a Cease and Desist Order against the above named Petitioners instructing them to cease operating an unlicensed insurance company in violation of RSA 406-B:3 and RSA 405:1; and to cease operating as an unlicensed Third Party Administrator in violation of RSA 402-H.
- B. On November 27, 2019, Petitioner Alieria Healthcare Inc. filed an Application for Hearing challenging the Department's issuance of the Cease and Desist Order.
- C. On November 29, 2019, Petitioner Trinity Healthshare filed an Application for Hearing, also challenging the issuance of the Cease and Desist Order.
- D. Pursuant to RSA 400-A:17, IV, a hearing shall be conducted December 30, 2019, from 10:00 a.m. to 12:00 p.m. at the offices of the NHID, located at 21 South Fruit Street, Suite 14 in Concord, New Hampshire.
- E. The hearing shall be conducted in accordance with RSA 541-A:31, RSA 400-A:17 *et seq.* and Ins Part 200.
- F. A Pre-hearing Conference is scheduled for December 17, 2019 from 10:00 a.m. to 12:00 p.m. at the offices of the NHID. The pre-hearing conference shall be conducted pursuant to RSA 541-A:31 and Ins Part 200.

G. Michelle Heaton shall preside as the Hearing Officer in this matter. Linda Zalinskie shall serve as clerk to the Hearing Officer.

K. The Petitioner has the right to be represented in this proceeding per INS 203.04, at their expense. Should the Petitioner designate a representative, then they shall file a Notice of Appearance with Ms. Zalinskie at the earliest possible date.
